



## SKI FOR FREE WINTER 2019 - 2020

### RULES AND REGULATIONS

The Tourism Consortium Monterosa in collaboration with Monterosa SpA are pleased to offer the Ski For Free 2019-2020 promotion for all or part of the valid periods (see below) as approved by Monterosa SpA.

Each hotel/residence is free to establish limited periods within which the Ski For Free offer may be applied. As such, guests should verify that their hotel/residence do actually offer Ski For Free for their chosen holiday period, **PRIOR** to booking.

The Ski For Free 2018 – 2019 promotion will **ONLY** be bookable up to **7 days prior to the arrival date**, with the total payment made **IN ADVANCE** and **NOT REFUNDABLE**. The Ski For Free offer is not available for bookings made less than 7 days prior to the arrival date.

#### **SPECIAL – 3, 4 & 5 star HOTELS**

The 3, 4 & 5 star hotels guarantee a free skipass per person, valid for the number of nights booked in the hotel.

#### **SPECIAL – 2 star HOTELS, B&B, AFFITTACAMERE, REFUGES, RTA**

The 2 star hotels, B&B, Affittacamere, Refuges and RTA offer each of their guests the possibility to purchase a skipass valid for the number of nights booked, at 50% discount on the Monterosa Ski price list.

#### **Validity and Minimum Stay**

The Ski For Free 2019 - 2020 offer will be valid during the following periods:-

##### **DECEMBER 2019**

- From the 6<sup>th</sup> to the 24<sup>th</sup> December 2019 for all areas

##### **JANUARY 2020**

- From the 4<sup>th</sup> of January to the 2<sup>nd</sup> of February – for the Center\*
- From the 4<sup>th</sup> of January to the 9<sup>th</sup> of February– all the other villages\*\*

##### **MARCH-APRIL 2020**

- From the 21<sup>st</sup> of March until the 14<sup>th</sup> of April – for the Center\*
- From the 14<sup>th</sup> of March until the 14<sup>th</sup> of April – all the other villages \*\*

For the above indicated periods, the following regulations will apply:-

## SKI FOR FREE WINTER 2018 – 2019

- Minimum 3 nights stay during the week (Monday – Friday) with skipass valid for the number of nights booked in the hotel.
  - Any booking for more than 3 nights during the week may have a reduced number of skipass days however, never less than the minimum above indicated.
- Minimum 4 nights stay if booked over a weekend (eg. Friday to Monday) with skipass valid for the number of nights booked in the hotel.
  - A booking for more than 4 nights over a weekend may have a reduced number of skipass days but never less than the minimum above indicated.
- Minimum 6 night stay during December
- The hotel/residence may have established different minimum stay rules, possibly for longer than the valid Ski For Free regulations for a specified period (eg. in January minimum 6 nights).
- **Exclusively in the December period the promotion is valid only for a minimum period of 6 nights.**

**\*Center: Champoluc, Frachey, Gressoney-La-Trinité, Stafal, Alagna and Riva Valdobbia**

**\*\*all the other villages in the three valleys with exclusion of the one considered “Center”**

### Booking Procedure

The guest should contact the hotel/residence of interest. Should the hotel’s proposal be of interest, the guest should book directly with the hotel, specifying the first ski day, the number of days skipass required based upon the above regulations and whether they wish to purchase the skipass insurance cover. The hotel/residence will organize the guest’s holiday in compliance with the Ski For Free regulations.

It is **IMPORTANT** to advise guests that piste rescue costs €200 per rescue. Should an accident occur on the piste, the insurance cover will operate **ONLY if the Piste Rescue team has been called to the scene**. Insurance cover (if required) should be requested at the time the skipass is booked at a cost of €2,00 per day per person.

The multi-day Ski For Free skipass will be valid for the entire MonterosaSki ski area including the ski lifts in Champoluc, Frachey, Brusson, Antagnod, Gressoney-La-Trinité, Gressoney-Saint-Jean, Alagna Valsesia and Champorcher.

The skipass Key cards issued may be returned after use, **ONLY** and exclusively to the hotel/residence and **NOT** to the ticket offices.

The Ski For Free skipasses are not available separately from the valid hotel/residence booking.

### PENALTIES

Monterosa SpA and the Tourism Consortium Val d’Ayas Monterosa reserve the right to spot check guests at any time to verify compliance with the Ski For Free promotion rules and regulations. The Ski For Free skipass, as all other skipasses, are nominative, personal and not usable by third parties. In the case of serious irregularities on the part of clients, Monterosa SpA reserve the right to take appropriate legal action and administer fines.

## SKI FOR FREE WINTER 2018 – 2019

The skipasses should always be checked against the receipts and documents delivered with the skipass which should indicate the name and surname, the insurance cover and the days for which the skipass is valid.



### **MODIFICATIONS/ CANCELLATIONS**

Full payment should be made for the Ski For Free promotion at the time of booking.

Payments made for the Ski For Free promotion are NOT REFUNDABLE under any circumstances.

Should the booking be annulled by the client, NO REFUNDS will be available from the hotel/residence.

In the case of unfavourable weather conditions at the beginning of the season (lack of snow), the guests will be permitted to move their booking to another date within the Ski For Free periods (subject to availability), however the number of nights (and as such the number of skipass days) cannot be modified.

The present agreement is signed and sealed to facilitate this offer and to guarantee the procedural cohesion for the Ski For Free 2019-2020 winter season offer.
